The following fee schedule can be used as a guide for clients in estimating potential costs of services. It is not intended as a prescription of the services required or a guarantee of the total costs for a particular client. While these are the costs that we may bill, insurance companies that we are in-network with may have negotiated lower rates and your cost may vary. Additional procedure codes not listed may be billed if medically necessary.

Many of the procedures listed below may not be required or ever billed for a particular client. We know that understanding insurance coverage and costs can be complicated. The following is an example scenario to demonstrate cost estimation:

Scenario 1:

A young adult was referred to Uplift AT for an "AAC Evaluation" by her pediatrician. The first appointment scheduled is a Comprehensive Speech and Language Evaluation (\$390) as that information is needed as a part of a prescription for an AAC device. Following the initial evaluation, typically between three to six speech therapy sessions (\$135 per session) are scheduled in which the client will trial various AAC programs. At the end of the trial period, an Evaluation for a Speech Generating Device (\$250) will be completed which will prescribe the best AAC system and include funding the device through insurance. After the client receives the device, additional programming and modification sessions may be scheduled (\$180) if customization is needed.

Scenario 2:

A preschool child was referred to Uplift AT for ongoing AAC therapy and support with device customization. The child already has an AAC device that the family purchased. The first appointment is a Comprehensive Speech and Language Evaluation (\$390) that determines the child's current language skills with spoken speech, with their device, and with other modes of communicating. A treatment plan is developed with the family and ongoing sessions are scheduled. Sessions are billed ongoing as speech therapy (\$135) and/or programming/training of a device (\$180) depending on the content of each session.
